SUBJECT: Modification to List of Protective Clothing Allowed, 33 USC 569

1. References:

a. Title 33, United States Code Section 569, Personal equipment for employees; use of funds for purpose.


b. Rescinded EFARS clause 17/9002.

2. 33 U.S.C. 569 authorizes the Chief of Engineers to expend Civil Works appropriations for the purchase of such personal equipment for employees as in his opinion are "essential for the efficient prosecution of the works." To that end, EFARS clause 17/9002 (e), "Special Protective Equipment for Employees", Change 1, dated 15 January 1985, identified specific items that the Chief of Engineers determined to be essential for that purpose. Furthermore, paragraph (e) delegated the authority to approve requests for necessary equipment, which was not listed therein, to FOA Commanders.

3. EFARS clause 17/9002 was rescinded, along with many other EFARS clauses, in an effort to reduce the number of subordinate acquisition clauses utilized by the U. S. Army Corps of Engineers. While the Chief of Engineers' previous determination regarding personal equipment was also rescinded as a result of this action, the personal equipment determined to be essential for the efficient prosecution of the mission remain necessary for that purpose.

4. In accordance with the authority granted to me under 33 U.S.C. 569, I approve the use of Civil Works appropriations to purchase the personal equipment detailed in the enclosure to this memorandum. If items of equipment not listed therein are considered essential for the efficient prosecution of the Works, requests for authority to purchase these items will be approved by the FOA Commander.
