SUBJECT: Natural Resource Management Gateway Initiative – Field Review Group
Appointments

1. References:

a. Memorandum, CECW-ON, 20 September 2000, subject: Natural Resource Management (NRM) Website Development Initiative. This initiative has been renamed the NRM Gateway Initiative, and the website was launched in April 2001 at this address: <http://corpslakes.usace.army.mil/>

b. Memorandum, CECW-ON, 16 March 2001, subject: Natural Resource Management Gateway Initiative – Field Review Group

2. The referenced memorandum 1.b appointed members of the NRM Gateway Field Review Group (FRG). The FRG is requested periodically to access and review the website, and to provide specific comments on site functionality and accessibility. The Group also provides advice on development priorities. The initial appointments were for a one-year period, with indefinite extensions. It is time to survey the FRG membership to determine their willingness to serve in this capacity, and to appoint a Lead FRG member to coordinate their activities.

3. Mr. Kevin Salvilla of the Jacksonville District is appointed the Lead FRG member, with the following duties:

a. Canvass original appointees to see if they wish to continue, and recruit replacements as needed to maintain appropriate field representation;

b. Manage the FRG membership list, the associated email address list, and communications with the FRG;

c. Identify smaller focus groups within the FRG and establish/manage associated email address lists to review Gateway items (1) of special interest, (2) needing quick review, or (3) requiring specialized knowledge for adequate review;

d. Manage the master list of Gateway items (i.e., FRG feedback and Gateway improvements/concerns submitted by others) already considered or which await consideration by the NRM Gateway Working Group;

e. Serve as a member of the NRM Gateway Working Group.

4. Mr. Salvilla will contact current FRG members to verify their willingness to continue to serve. Selections to replace members who no longer wish to serve will be made contingent upon final approval of each nominee's supervisor.
